**DEMAND-BASED COLLABORATION:** We listen to our members and engage with countries that have promising economic outlooks. We will engage with local embassies, meet with relevant U.S. Government officials, and even take a trade mission if there is enough interest.

**MEET WITH SENIOR U.S. GOVERNMENT OFFICIALS:** The American-Central European Business Association works with members of Congress and senior-level U.S. Government officials to ensure that company issues are heard from various angles.

**BUSINESS STRATEGY:** ACEBA leverages its position to advocate for company needs in any of the respective countries.

## **Structure**
